License/certification:

License to practice Veterinary Medicine in the State of Wisconsin (or eligibility to obtain) **is preferred**. Academic licensure as a University of Wisconsin employee is available with the following requirements.

Degree and area of specialization:

Applicants must have a DVM **or equivalent degree**. Experience in diagnostic pathology and completion of at least two years of post-DVM training in a recognized veterinary anatomic pathology program is also required.

ACVP/AAAP/ECVP* board certification or **eligibility for Phase II of board certification** is required. Board certification is preferred. **Renewal requires board certification within three years of hire date. **

*(American College of Veterinary Pathologists/American Association of Avian Pathologists/European College of Veterinary Pathologists)

Practice limitations with academic licensure at WVDL: A pathologist working with an Academic License may only perform euthanasia under the direct supervision of a Wisconsin Licensed DVM. Academic licensed pathologists may not directly coordinate any accession without a referring DVM or practice veterinary medicine directly with animal owners.
