## **2024 Spongy Moth Slow the Spread Program:** Chart of Treatment Sites and Completion Dates

## Updated: 17-May-2024

- The 2024 Slow the Spread Program has planned treatments for 23 sites in the following nine counties: Barron, Buffalo, Chippewa, Crawford, Dunn, Grant, Iowa, Lafayette, and Rusk.
- Sites will be treated with one of the following organic products: *Bacillus thuringiensis* var. *kurstaki* (Btk) or Mating Disruptor (MD). Generally, Btk is applied in late spring, and MD treatments take place in early summer.
- Aerial treatments depend on good weather and proper flying conditions. Therefore, dates are usually determined on a dayto-day basis. Changes in schedule may occur due to weather, logistical or mechanical problems.
